**Summary:** The U.S. Mission in Bujumbura, Burundi is seeking eligible and qualified applicants for the position of **Class B Cashier**.

**The work schedule for this position is** Full Time (40 hours per week).

**Start date:** Candidate must be able to begin working within a reasonable period of time of receipt of agency authorization and/or clearances/certifications or their candidacy may end.

**Supervisory Position:** No

**DUTIES:**

Performs Class B Cashier functions. Makes collections of consular fees, makes payments for official goods and services. Performs accommodation exchange.

**QUALIFICATIONS AND EVALUATIONS:**

**EDUCATION:** Completion of two years' university in accountancy or equivalent required.

**REQUIREMENTS:**

**EXPERIENCE:** Four years of progressively responsible work in technical accounting or bookkeeping with at least two years performing cashiering work, and one of the two years must be at the next level in a U.S. agency, or the equivalent.

**JOB KNOWLEDGE:** A very good working knowledge of collection and disbursing functions in an automated accounting system.

**EVALUATIONS:**

**LANGUAGE:** English level III (Good working knowledge) Reading/Writing/Speaking is required. French level IV (Fluent) Reading/Writing/Speaking is required. Kirundi level IV (Fluent) Reading/Writing/Speaking is required.

**SKILLS AND ABILITIES:** Must have ability to deal with clients in a tactful and courteous manner. Ability to analyze accounting transactions sufficiently to detect errors and reconcile account. Understanding of work processing and spreadsheet software. Ability to operate a computer and a 10-key adding machine.

**Qualifications:** All applicants may be tested on any requirements listed above. All applicants under consideration will be required to pass medical and security certifications. All candidates must be able to obtain and hold a Local Security Certification.

**EQUAL EMPLOYMENT OPPORTUNITY (EEO):** The U.S. Mission provides equal opportunity and fair and equitable treatment in employment to all people without regard to race,

color, religion, sex, national origin, age, disability, political affiliation, marital status, or sexual orientation.

**Benefits:** Locally employed staff, including members of household (MOHs), and third-country nationals (TCNs), working at the U.S. Mission in Bujumbura, Burundi, may receive a compensation package that may include health, separation, and other benefits.

**HIRING PREFERENCE SELECTION PROCESS:** Applicants in the following hiring preference categories are extended a hiring preference in the order listed below. Therefore, it is essential that these applicants accurately describe their status on the application. Failure to do so may result in a determination that the applicant is not eligible for a hiring preference.

**HIRING PREFERENCE ORDER:**

- (1) AEFM / USEFM who is a preference-eligible U.S. Veteran\*
- (2) AEFM / USEFM
- (3) FS on LWOP and CS with reemployment rights \*\*

\* **IMPORTANT:** Applicants who claim status as a preference-eligible U.S. Veteran must submit a copy of their most recent DD-214 (“Certificate of Release or Discharge from Active Duty”), equivalent documentation, or certification. A “certification” is any written document from the armed forces that certifies the service member is expected to be discharged or released from active duty service in the armed forces under honorable conditions within 120 days after the certification is submitted by the applicant. The certification letter should be on letterhead of the appropriate military branch of the service and contain (1) the military service dates including the expected discharge or release date; and (2) the character of service. Acceptable documentation must be submitted in order for the preference to be given.

\*\* This level of preference applies to all Foreign Service employees on LWOP and CS with re-employment rights back to their agency or bureau.
